After some deliberations WM announced that he would have a word with the Treasurer and decide on the final figure of reduction in subscription for the year ending 30.9.2021.

*Since confirmed by WM that the subscription could be finalized at Rs. 2250 and the excess amount already paid by any brethren be treated as advance subscription or refunded as appropriate.
